## II. DESCRIPTION OF LEASED MATERIAL:

The Lender agrees to lease to the Borrower the following described material:

## III. USE OF LEASED MATERIAL:

- ✓ The borrower declares that he/she is a qualified and experienced climber and that he/she is aware of the use of this material and the rope as well as their combination. This includes but is not limited to the correct use of the climbing harness, the correct use of the belay devices (e.g. tube style, assisted braking devices ...), mastery of the crucial belaying and falling techniques, correct roping-up using figure-eight knot or bowline on a bight and compliance with the braking hand principle (one hand always remains on the brake line). The staff of Sunclimbing are not obliged to check the borrowers' ability to belay correctly or to control their adherence of user guidelines and safety instructions.

# CLIMBING MATERIAL LEASE AGREEMENT



- ✓ The borrower acknowledges that the equipment is in a good working condition and that he/she has examined the equipment to ensure that it is free of damages.
- ✓ The borrower is liable for costs in the event of willful damage, misappropriation and the necessary repair, for subsequent additional effort (cleaning, removal of stickers, etc.). In the case of minors, the legal guardian(s) is liable. In case of loss the rental material will be replaced at the original price and in case of damage the repair prices will be invoiced at the cost price.
- ✓ The borrower acknowledges that he/she returns the material in a cleaned condition and that he/she will pay a cleaning fee, if necessary.

## IV. LENGTH OF LEASE:

- ✓ In order to ensure the availability of the articles for other borrowers, Sunclimbing expects that the borrowed material will be returned cleanly and punctually on the date stated in this agreement.
- ✓ If the borrower misses the return date, Sunclimbing may charge a reminder fee. If the borrowed material includes urgently needed items, Sunclimbing will reclaim the items by telephone or in writing and may charge further fees for any activities incurred.
- ✓ The rental period is adapted to the needs, i.e. there is no maximum rental period. For reasons of material wear and tear a surcharge for longer rental periods applies:
  - 10 days / 2 weekends: + 25%
  - 14 days: + 50%
  - 21 days: + 75%
  - 28 days: + 100%
  - additional month: + 100% each
